THE STATE-WIDE PETITION TO STOP THE ABORTION AGENDA IN ARKANSAS

Arkansas Right to Life, the largest and oldest state-wide pro-life organization, and its affiliate chapters, are sponsoring a state-wide petition to oppose the pro-abortion agenda of the federal government and planned parenthood, and to advance vital pro-life legislation to protect unborn children.

The newly passed Obama Health Care Law, known as the Patient Protection and Affordable Care Act, contains dangerous provisions which provide abortion-related coverage in government-funded health care exchanges. Arkansas must join the states to explicitly remove themselves. Concurrently, Planned Parenthood, the nation's largest abortion provider, is expanding their abortion services through the use of web-cam abortions, in which an abortionist prescribes use of the deadly RU-486 abortifacient via a web-cam, without any contact with the patient in person. This dangerous practice must be banned. Also, several states have recently passed legislation banning abortion after an unborn child is capable of feeling pain, which is at 20 weeks. With the support of pro-lifers across the state, Arkansas can become the next state to protect pain-capable unborn children.

1. Please collect signatures on the petition from your friends, family, and neighbors. Arrange to have petitions signed at your churches, fairs, shopping centers, sporting events, and any meetings where there may be pro-life people.

To avoid delay in signing before and after meetings or church services, it is advisable to have an adequate number of petition copies. Use only one side of each sheet. 3. ADVERTISE the petition by an announcement at meetings and other appropriate venues. PETITION TO STOP THE ABORTION AGENDA IN ARKANSAS
You are invited to sign a petition to the governor of Arkansas and members of the General Assembly that will support an opt-out of abortion-related coverage in the Obama Health Care Law for Arkansas, ban web-cam abortions in Arkansas, and the passage of a ban on abortion of pain-capable unborn children in Arkansas. 4. Choose a convenient method of gathering signatures. Use a long table or several card tables, or utilize a number of clipboards with petitions and pens on them.
